(1) From those provisions of the U.S. Constitution which vest in the President the power to make treaties and appoint ambassadors, other public ministers, and consuls, by and with the advice and consent of the Senate; *and*

(2) To conduct foreign affairs from 22 U.S.C. 2656; *and*,

(3) Other authorities, as appropriate.

- (b) Political-military;
- (c) Weapons proliferation;
- (d) Multilateral organizations;
- (e) Labor and social affairs;
- (f) Narcotics;
- (g) Environment;
- (h) Refugees;
- (i) Human rights;
