Chapters in the 7000 series of 3 FAM 7000 contain the major portion of regulations, guidelines and procedures for the administration of a Foreign Service National (FSN) personnel program, which includes nationals of the host country and third-country nationals (TCN's). These regulations, procedures, and guides are applicable to each State, USAID, USIA, Commerce, and Agriculture overseas establishment, unless otherwise indicated.

3 FAM 7111.3 Responsibility of Chief of Mission
