5 FAH-2 H-251 SPECAT—MILITARY SPECIAL CATEGORY

(TL:TEL-2; 05-23-2002)
(Uniform all agencies)

SPECAT (special category) is a transmission method used by the military to restrict dissemination of sensitive information. Consult the user's manual for Information Programs Center's (IPC) telegraphic processor for specific format requirements. If the user's manual has no SPECAT format instructions, use guidance in this subchapter.

5 FAH-2 H-251.1 Military Address Pattern

(TL:TEL-2; 05-23-2002)
(Uniform all agencies)

If the telegram is drafted by the post's defense attaché office (DAO) and addressed to a military activity, SPECAT must appear after the classification on the first line of the pseudo header and after the classification one line after the last addressee. See 5 FAH-2 Exhibit H-251.1.

5 FAH-2 H-251.2 Civilian Address Pattern

(TL:TEL-2; 05-23-2002)
(Uniform State/USAID)

If the message is drafted by a Department office and addressed to other Department missions and military activities, the message combines the basic format of an outgoing Department telegram with the military format. See 5 FAH-2 Exhibit H-251.2.

5 FAH-2 H-252 AUTOMATED MESSAGE ANALYSIS AND DISSEMINATION SYSTEM (AMADS) REQUIREMENTS

*(TL:TEL-11; 07-19-2004)
(Uniform State/USAID)*

a. Automated Message Analysis and Dissemination System (AMADS) is the telegraphic processor used in the Main State Messaging Center (IRM/OPS/MSO/MSMC). It disseminates telegrams based on:

- (1) Captions (see list in 5 FAH-2 H-440);*
- (2) Attention indicators (see 5 FAH-1 H-216.5);*
- (3) Passing instructions (see 5 FAH-1 H-216.5);*
- (4) TAGS (see 5 FAH-1 H-217.2 and 5 FAH-3); and*
- (5) Subject terms and key words (see 5 FAH-2 H-244 and 5 FAH-3).*

b. Drafters must enter correctly all handling instructions, TAGS, and terms, to ensure a telegram addressed to the Department is delivered to the correct office/officer. All entries, such as attention indicators, TAGS, or terms, must be spelled exactly as in the referenced material.

c. The Department periodically sends out updates of proper formatting procedures resulting from continuous analysis of telegraphic traffic processed by AMADS. Drafters must be aware of the items addressed in these updates to ensure optimum processing of telegraphic traffic.

5 FAH-2 H-252.1 Handling Instructions

*(TL:TEL-11; 07-19-2004)
(Uniform State/USAID)*

The Main State Messaging Center (IRM/OPS/MSO/MSMC) recommends that drafters use captions and attention indicators with individual office symbols followed by an individual's name to route the telegram to specific offices or officers. See 5 FAH-2 H-240 for more information on handling instructions.

5 FAH-2 H-252.1-1 Captions

(TL:TEL-11; 07-19-2004)
(Uniform State/USAID)

a. Whenever possible, drafters should assign a single caption to route a telegram most effectively. The drafter may list a single special handling caption, entering it as the first caption. If more than one caption is used, each caption occupies a separate line.

b. You may use STADIS with EXDIS or NODIS. However, the most restricting caption must appear first; all captions should be placed on separate lines below. See 5 FAH-1 H-216 and 5 FAH-2 H-440 for more information on how to use captions.

5 FAH-2 H-252.1-2 Official Informal

(TL:TEL-11; 07-19-2004)
(Uniform State/USAID)

OFFICIAL INFORMAL must appear on the caption line and on the SUBJECT line followed by an attention indicator for a particular office or bureau. AMADS will then disseminate OFFICIAL INFORMAL telegrams to the indicated office and Executive Secretariat (S/ES-O). If a telegram carries an additional caption, the dissemination profile for that caption may take precedence over the OFFICIAL INFORMAL dissemination profile. See 5 FAH-1 H-216.3 and 5 FAH-2 Exhibit H-252.1-2 for more information on OFFICIAL INFORMAL.

5 FAH-2 H-252.1-3 Attention Indicators

(TL:TEL-11; 07-19-2004)
(Uniform State/USAID)

a. Use attention indicators to narrow the distribution of a telegram.

b. See 5 FAH-1 H-216.5 for information on use and format of attention indicators.

5 FAH-2 H-252.2 TAGS

(TL:TEL-11; 07-19-2004)
(State only)

a. The telegram processor examines the TAGS line to use as one of a set of criteria for dissemination. It uses TAGS in conjunction with captions, attention indicators, and subject keywords to match against pre-programmed criteria sets for different distribution patterns. When it gets a

match, it assigns that distribution pattern to the telegram.

b. Program TAGS (K TAGS) may be used only after an initial Subject TAGS entry.

c. The drafter may use proper names and organizations on the TAGS line only after an initial Subject TAGS entry. The name(s) must be enclosed in parentheses: last name, first name, and then middle initial (without a period). For example:

TAGS: APER, (DOE, JOHN M), (DOE, JANE S).

d. Refer to the 5 FAH-3 TAGS/TERMS Handbook, for more detailed information on TAGS and TERMS.

5 FAH-2 H-252.3 Subject Line and Terms

(TL:TEL-11; 07-19-2004)
(Uniform State/USAID)

a. Automated Message Analysis and Dissemination System (AMADS) is programmed to parse the subject line for terms or keywords to assign the action responsibilities as determined by Department offices or other agencies. AMADS then passes the telegram to the appropriate dissemination queue for delivery to the offices associated with that queue.

b. TERP V uses pre-programmed terms, on the subject line, as subject keywords, one of the criteria used to assign dissemination symbols to an incoming telegram.

c. See 5 FAH-3, TAGS/Terms Handbook, for more information on using and creating Terms.

5 FAH-2 H-253 ZEN FORMAT

(TL:TEL-2; 05-23-2002)
(Uniform all agencies)

a. The operating signal ZEN indicates delivery via other means. This could be due to the recipient addressee not having electronic communications, or if the drafter wants to send the telegram by pouch (see 5 FAH-2 H-253.1).

b. The drafter lists the addressee as info or action, as appropriate, preceded by the operating signal "ZEN."

c. See 5 FAH-1 H-223.5 and 5 FAH-2 Exhibit H-253 for an example.

5 FAH-2 H-253.1 Pouch

(TL:TEL-11; 07-19-2004)
(Uniform State/USAID)

a. The drafter can send a telegram to an addressee by pouch. This is marked on the telegram using the operations signal, ZEN, in conjunction with the handling symbol POUCH. The telegram is then enveloped and sent, as appropriate, by unclassified pouch or diplomatic courier pouch to the designated addressee.

b. You may send UNCLASSIFIED and Sensitive But Unclassified (SBU) telegrams by unclassified pouch or U.S. mail. Classified and SBU NOFORN telegrams must be registered and sent via diplomatic courier pouch or U.S.-controlled postal facilities in accordance with the regulations for other documents of similar classification or control designation.

5 FAH-2 H-253.2 Fax

(TL:TEL-2; 05-23-2002)
(Uniform State/USAID)

The Department no longer uses Direct Relay procedures to forward telegraphic text from posts abroad to organizations or individuals outside the Diplomatic Telecommunications Network (DTS) network. Facsimile services present a viable alternative and are available worldwide. If a telegram is delivered via fax, mark the telegram as outlined in 5 FAH-2 H-253 above.

1. (U) This is an example of an EXDIS/SPECAT EXCLUSIVE telegram addressed to both a military and Department addressee. Note the placement of the EXDIS caption and the SPECAT handling instruction. If a Department of State facility is an addressee, format the telegram per Department of State regulations and place the SPECAT or SPECAT EXCLUSIVE handling instruction after the classification on the first line so the telegraphic processor inserts the security warning opsign /BBBBB on FL-4. Also, if the telegram is addressed to a Department of State addressee, the Ambassador is the approving officer and classification authority.
