MAJOR CHANGES

1. **6 FAM 720** has been reissued only to correct the contents of two exhibits. No other changes have been made:

- **6 FAM 724 Exhibit 724.7A:** The title of this exhibit is now Space Standards Charts Shown in Square Feet and (Meters). The columns and rows of this exhibit were out of alignment;
- **6 FAM 724 Exhibit 724.8C:** Conversion Table Metric/English Measure: The square feet to square meters equation table title was erroneously reversed.

Under the Foreign Affairs Reform and Restructuring Act of 1998, Public Law 105-277, the functions of the U.S. Information Agency related to International Broadcasting are transferred to the Broadcasting Board of Governors. Accordingly, all provisions of the FAM previously applicable to USIA continue in effect with respect to the BBG until further notice.

5. Officers are reminded that Department-issued materials not codified in the *Foreign Affairs Manual* or its supplemental *Foreign Affairs Handbook* series generally have no regulatory validity (see 2 FAM 1115.2).

FILING INSTRUCTIONS FOR PAPER COPIES

1. Remove and discard old 6 FAM subchapter 720 (issued under TL:GS-60, 12-22-1999; 49 pages total) and replace it with the corrected 6 FAM subchapter 720 (49 pages).

2. After inserting the material in the binder, insert this transmittal letter immediately following the TL Checklist, then fill in the entry line for TL:GS-78, and initial.
