THE STATION'S CANDID REPLY IN REFERENCE A CONCERNING THE LIMITATIONS GOVERNING THE [REDACTED] PROGRAM IS MUCH APPRECIATED BECAUSE IT PROVIDES AN EXCELLENT BASIS FOR FURTHER REFINING THE GROUND RULES WHICH MUST GOVERN THE CONDUCT OF THE [REDACTED] PROGRAM FOR THE FORESEEABLE FUTURE. WE HOPE THAT THE FOLLOWING COMMENTS WILL EXPLAIN AND DEFINE THE LIMITATIONS ON [REDACTED] OPERATIONS AS WELL AS PROVIDE PRACTICAL AND ACCEPTABLE GUIDELINES FOR THE FUTURE.

2. ANY DISCUSSION REGARDING POSSIBLE [REDACTED] SUPPORT OF AN ATTEMPTED COUP IS OBVIOUSLY HIGHLY SENSITIVE. SINCE WE DO NOT HAVE [REDACTED] APPROVAL TO BECOME INVOLVED IN ANY COUP PLANNING, WE CANNOT ACCEPT YOUR CONCLUSION IN REFERENCE A THAT THE [REDACTED] MISSION IS TO 'WORK CONSCIOUSLY AND DELIBERATELY IN THE DIRECTION OF A COUP', NOR CAN WE AUTHORIZE YOU TO 'TALK FRANKLY ABOUT THE

MECHANICS OF A COUP WITH KEY COMMANDERS, BECAUSE THE IMPLICATIONS OF THAT AMOUNT TO THE SAME.

3. ON THE OTHER HAND, THE MONITORING AND REPORTING OF ACTIVITIES, EVENTS AND ATTITUDES OF THE CHILEAN ARMED FORCES AND THEIR LEADERS HAS BECOME INCREASINGLY IMPORTANT.

4. WE RECOGNIZE THE DIFFICULTIES INVOLVED IN YOUR MAINTAINING INTEREST AND DEVELOPING THE CONFIDENCE OF MILITARY OFFICERS WHEN WE ARE ONLY SEEKING INFORMATION AND HAVE LITTLE OR NOTHING CONCRETE TO OFFER IN RETURN

IN ADDITION, THERE IS NO REASON THAT STATION OFFICERS, ON A 'STRICTLY PERSONAL' BASIS, CANNOT LISTEN ATTENTIVELY TO OFFICERS WHO WISH TO VOLUNTEER INFORMATION ABOUT COUP PLANNING OR PLOTTING SINCE THIS IS PART OF THE ESSENTIAL COLLECTION PROGRAM. THERE IS OF COURSE A RATHER FINE DIVIDING LINE HERE BETWEEN MERELY 'LISTENING' AND TALKING FRANKLY ABOUT THE MECHANICS OF A COUP WHICH IN THE LONG RUN MUST BE LEFT TO THE DISCRETION AND GOOD JUDGMENT OF THE INDIVIDUAL CASE OFFICER. PLEASE ERR ON THE SIDE OF GIVING

THE POSSIBLY INDISCREET AND PROBABLY UNCONTROLLED CONTACT LITTLE TANGIBLE MATERIAL WITH WHICH TO ACCUSE US.

5. THE ESSENTIAL FACT WHICH MUST BE KEPT IN MIND BY ALL OFFICERS CONNECTED WITH THE [REDACTED] PROGRAM IS THAT WE DO NOT HAVE ANY AUTHORITY TO STATE, OR EVEN TO IMPLY, THAT [REDACTED] FAVORS A COUP AS A SOLUTION TO THE CHILEAN DILEMMA. IF AND WHEN STATION REPORTING INDICATES A FAVORABLE POLITICAL ATMOSPHERE AND A SERIOUS MILITARY INTENT TO TAKE ACTION AGAINST THE ALLENDE GOVERNMENT, IT WILL BECOME THE RESPONSIBILITY OF OTHER APPROPRIATE [REDACTED] AUTHORITIES TO USE THIS INTELLIGENCE IN REACHING A POLICY DECISION. [REDACTED] MIGHT OR MIGHT NOT AT THAT TIME REQUEST SUCH A DECISION FROM [REDACTED] WE JUST CANNOT SAY AT THIS STAGE OR SEEK ADVANCE ADVICE ON THE BASIS OF HYPOTHESIS. POLICY DOES NOT WORK THAT WAY.

6. THE STATION MUST BE AS WELL PREPARED AS POSSIBLE TO PROVIDE THE INTELLIGENCE AND ASSESSMENTS WHICH WILL BE NEEDED IN MAKING SUCH A DECISION, IF IT COMES TO THAT, BUT MUST NOT ANTICIPATE WHAT THE DECISION MAY BE. ABOVE ALL, WE MUST AVOID ENCOURAGING OUR [REDACTED] CONTACTS TO BELIEVE THAT [REDACTED] SUPPORT WILL BE AVAILABLE, SINCE SUCH A BELIEF COULD NOT ONLY PROVE FALSE BUT COULD ALSO ENCOURAGE THEM TO UNDERTAKE PREMATURE, ABORTIVE, AND CERTAINLY UNSUPPORTED ACTION.

7. WE TRUST THIS INTERCHANGE HAS SERVED TO CLARIFY FOR THE STATION THE OBJECTIVES OF AND GUIDELINES FOR THE
